## Rules of the referral program.

- 1. The following terms are used in these rules of referral program:
  - Bonus a remuneration of a Member for taking active actions for the attraction of Users to the Service, which is determined in accordance with these Rules and information specified on the website <a href="https://tothemoon.game">https://tothemoon.game</a>.
  - Company a legal entity «ToTheMoon Development LTD.», registered in accordance with Cyprus legislation, registration number HE 396658, legal address Ancaion, 35 5th floor, Flat / Office 17, 1101, Nicosia, Cyprus.
  - Violation of the Rules actions of the Member contrary to the Rules. An approximate list of such actions is specified in paragraph 6 of the Rules, herein this list is open.
  - User an individual using the Service.
  - Terms of Use is the agreement in the form of a public offer, which establishes the terms of using the Service and of participation of the Users in the games available on the Service for entertainment purposes.
  - Rules these rules of Referral Program.
  - Premium account a certain amount of additional functions of the Service that can be acquired and activated by the User in accordance with the Terms of Use.
  - Referral an individual who has registered in the Service through the referral link of the Member.
  - Program this referral program organized by the Company in order to acquire new Users to the Service and maintain current Users' interest in the Service.
  - Referral network a group of Referrals of the Member.
  - Service a website on the Internet (https://tothemoon.game) and a mobile application, the
    rightholder of which is the Company or its affiliates, and the right to use for which is
    granted to Users on the terms of the Terms of Use specified on the website
    <a href="https://tothemoon.game">https://tothemoon.game</a>.
  - Member term is specified in paragraph 2 of the Rules.
- 2. Users with a Premium account (hereinafter referred to as the Member) have the right to participate in this Program. Participation in this Program is carried out by the Member by directing a referral link to an individual who meets the User's eligibility requirements, specified in the Terms of Use. In case of registration of such an individual in the Service, this individual becomes the Referral of the Member.
- 3. The User becomes a Member from the moment of acquiring the Premium account. In case of a failure to pay for the Premium account for the next period by the User, the User ceases to be the Member until the re-activation of the Premium account; herein in case of the re-activation of the Premium account the Referral network remains in force.
- 4. The Member has a right to obtain the Bonuses in the following cases:

- Acquisition and activation of the Premium account by the Referral. Bonus is accrued for
  each activation or prolongation of the Premium account by the Referral. The size of this
  Bonus is specified on the website <a href="https://tothemoon.game">https://tothemoon.game</a>.

- 5. Bonuses shall be accrued to the Member within 10 days from the day the Referral performs the actions specified in paragraph 4 of the Rules, provided that there are no Violations of the Rules.
- 6. The Violations of the Rules are the following actions of the Member:
  - Use of illegal methods to acquire Referrals or any other artificial increase in the number of Referrals, activation of the Premium account by the Referrals or making bets by the Referrals.
  - Creating clones of the Service. Use an interface similar to the interface of the website or mobile application being a part of the Service, as well as use the logos and/or trademarks of the Company.
  - Use of the https://tothemoon.game domain or the name of the Company, as well as the Company's trademarks in the contextual advertising of Google Adwords and Yandex.Direct.
  - Use of automatic redirects, pop-up windows as well as any other intrusive types of advertising: PopUp, PopUnder, ClickUnder, Toolbar, etc.
  - Spam mailings or mailings on behalf of the Company's employees (email, messengers).
  - Use of push-advertising.
  - Use of cookie stuffing tool (cookie dropping).
  - Creating accounts in the Service using his/her/its own referral link.
  - Misleading potential Referrals regarding the content of the Service or the referral link.
  - Other actions that are contrary to these Rules.
- 7. In order to counter unfair participation in the Program or abuse by the Member when using Bonuses, the Company reserves the right to exercise other than explicitly specified in these Rules methods to verify the absence of Violations of the Rules, as well as the right to refuse to accrue bonuses to the Member.
- 8. The Company has a right to make changes to these Rules provided that a notice of such changes shall be sent to the Members by e-mail no later than 14 days from the moment/ of such changes. A Member shall be deemed to have accepted the new terms if the Member does not inform the Company of the intention to terminate participation in the Program within 5 business days from the date of receipt of such notification.
